

Aluminum Horizontal Slat Fence

Limited Supply-Only Warranty (USA & Canada)

Applies to: AluminumHorizontalSlatFence.com

This Limited Supply-Only Warranty ("Warranty") is provided by **AluminumHorizontalSlatFence.com ("AHSF")** to the original purchaser ("Purchaser") of aluminum horizontal slat fence products supplied by AHSF. This Warranty is limited to the coverage expressly stated below and is subject to the exclusions and limitations in this document.

1. Warranty Coverage

AHSF provides a limited warranty for qualifying manufacturing defects in aluminum structural components supplied by AHSF and for qualifying defects in the factory-applied liquid-painted or powder-coated finish. This is a supply-only warranty. Installation, labor, field workmanship, removal, reinstallation, and related services are not included.

2. Warranty Period

Aluminum Structural Components	15-Year Limited Warranty
Factory-Applied Liquid-Painted or Powder-Coated Finish	5-Year Limited Warranty

Warranty periods begin on the original date of purchase and apply only to the original Purchaser.

3. What Is Covered

- **Structural coverage:** Structural failure of aluminum structural components supplied by AHSF, but only where the failure is caused by a manufacturing defect.
- **Finish coverage:** The factory-applied liquid-painted or powder-coated finish is covered for five (5) years against peeling, blistering, or bubbling, but only where caused by a defect in the factory-applied finish under normal conditions.

4. Exclusions

This Warranty does not cover:

- Improper installation, handling, storage, maintenance, modification, misuse, abuse, accident, impact, or vandalism.
- Damage from storms, floods, fire, falling objects, ground or foundation movement, or other external events beyond AHSF's control.
- Normal fading, chalking, gloss reduction, color variation, weathering, scratches, chips, dents, abrasion, or other cosmetic wear.
- Damage or finish deterioration resulting from salt or coastal exposure, pool or industrial chemicals, harsh cleaning agents, standing water, dissimilar metals, or other corrosive conditions.
- Labor, removal, reinstallation, site access, equipment, freight, shipping, brokerage, duties, taxes, or other costs associated with a claim.
- Hardware, accessories, fasteners, hinges, latches, motors, automation components, or other items not supplied by AHSF.

5. Finish Disclaimer

Minor color variation, gloss reduction, gradual fading, chalking, and normal weathering of liquid-painted or powder-coated finishes over time are normal and do not constitute a defect. Replacement material, if provided, may not exactly match existing material because of normal aging, weathering, production variation, or changes in available finishes.

6. Warranty Claims

To submit a claim, the Purchaser must provide proof of purchase, photographs of the alleged defect, and a written description of the issue within the applicable warranty period. AHSF may require additional information, samples, measurements, or a reasonable opportunity to inspect the product before determining coverage. Submission of a claim does not constitute acceptance of coverage, and no work should be undertaken on AHSF's behalf without prior written authorization.

7. AHSF's Sole Obligation and Exclusive Remedy

If AHSF determines that a covered defect exists, AHSF's sole obligation and the Purchaser's exclusive remedy shall be, at AHSF's discretion, to repair the affected supplied component, replace the affected supplied component, or issue a credit or refund not exceeding the original purchase price actually paid for the affected component. AHSF is not responsible for labor, installation, removal, reinstallation, shipping, freight, access, equipment, finishing, loss of use, or other associated costs.

8. Transferability

This Warranty is non-transferable and applies only to the original Purchaser.

9. Limitation of Liability

To the maximum extent permitted by applicable law, AHSF shall not be liable for incidental, consequential, special, punitive, exemplary, or indirect damages, including loss of use, lost profits, lost revenue, business interruption, delay costs, or damage to other property. AHSF's total aggregate liability arising from or relating to any product shall not exceed the original purchase price actually paid to AHSF for the affected product.

10. Governing Law

This Warranty shall be governed by and interpreted in accordance with the laws of the jurisdiction in which the product was purchased.

11. Entire Agreement

This document constitutes the entire limited warranty provided by AHSF for the covered product and supersedes prior warranty representations concerning the same product. No dealer, installer, sales representative, contractor, or other third party is authorized to expand, modify, or create any warranty obligation on behalf of AHSF unless expressly agreed to in writing by AHSF.
